#### INVITATION TO BID

Procurement of Works for the Repair/Rehab of Classrooms at Maria Cristina High School-Ditucalan HS Annex

- The DepED-Iligan City Division, through its Bids and Awards Committee intends to apply the sum of Php1,106,997.22 being the Approved Budget for the Contract (ABC) to payments under the contract for Repair/Rehab of Classrooms at Maria Cristina High School-Ditucalan HS Annex. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The DepED-Iligan City Division now invites bids for, Repair/Rehab of Classrooms at Maria Cristina High School-Ditucalan HS Annex. Completion of the Works is required 120 Calendar Days. Prospective bidders must have an experience of having completed at least one (1) contract that is similar to the contract to be bid, and whose value, adjusted to current prices using the NSO consumer price indices, must be at least fifty percent (50%) of the ABC to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders. - Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five

percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from DepED-Iligan City Division and inspect the Bidding Documents at the address given below from 8am-12:00nn and 1pm to 5pm.

5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of PhP5,000.00.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

6. The DepED-Iligan City Division will hold a Pre-Bid Conference on August 2, 2017, 9:00A.M. at Conference Hall, DepED-Iligan City Division, Gen. Aguinaldo St., Iligan City, which shall be open only to all interested parties who have purchased the Bidding Documents.

7. Bids must be delivered to the address below on or before August 17, 2017, 9:00 .AM. at Conference Hall, DepED-Iligan City Division, Gen. Aguinaldo St., Iligan City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. A valid Bid Securing Declaration must accompany the bid(s) in lieu of the bid security.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The DepED-Iligan City Division reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
