#### INVITATION TO BID

Procurement of Supply and Delivery of School Furniture for Transferee Students Affected by Marawi Conflict CY 2017

- The DepED-Iligan City Division, through its Bids and Awards Committee intends to apply the sum of PhP1,112,300.00 being the Approved Budget for the Contract (ABC) to payments under the contract for the Procurement of Supply and Delivery of School Furniture for Transferee Students Affected by Marawi Conflict-CY 2017. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The DepED-Iligan City Division now invites bids for, Procurement of Supply and Delivery of School Furniture for Transferee Students Affected by Marawi Conflict-CY 2017. Delivery of Goods is required 90 Calendar Days. Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding documents, particularly, Section II instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".  
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from BAC Secretariat Office, DepED-Iligan City Division and inspect the Bidding Documents at the address given below from 8am-12:00nn and 1pm to 5pm.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of PhP5,000.00. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.
6. The DepED-Iligan City Division will hold a Pre-Bid Conference on August 15, 2017, 9:00A.M. at Conference Hall, DepED-Iligan City Division, Gen. Aguinaldo St., Iligan City, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered to the address below on or before August 29, 2017, 9:00 .AM. at Conference Hall, DepED-Iligan City Division, Gen. Aguinaldo St., Iligan City. All bids must be accompanied by a bid a security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bid opening shall be on 9:00 AM, August 29, 2017 at Conference Hall, DepED-Iligan City Division, Gen. Aguinaldo St., Iligan City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. The DepED-Iligan City Division reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
