REITERATION OF SALIENT POINTS OF DEPED INTERNET CONNECTIVITY PROJECT (DICP)

DATE: March 22, 2016

- To improve the utilization of DepEd Internet Connectivity Project (DICP) of this Division, you are hereby advised to revisit DepEd Order No. 50 and No. 113, s. 2009, and DepEd Order No. 46, s. 2011.
- 2. The following salient points are listed below, to wit:
  - Schools shall directly subscribe to their local Internet Service Provider (ISP) in accordance with RA 9184. (DO No. 113, s. 2009);
  - b. Schools are allowed one connection only. (DO No. 113, s. 2009);
  - c. The allotted budget for the said internet subscription is Forthy Eight Thousand Pesos (Php 48,000.00) per annum per school. The said amount shall be downloaded by the Budget Division directly to the high schools. Expenses incurred in the connection with this undertaking shall be charged against the Maintenance and Other Operating Expenses (MOOE) fund for the DepED internet Connectivity Project (DICP) under the DepED Computerization Program. (DO No. 50, s. 2009);
  - d. Schools are advised to initially cover the first monthly subscription amounting to Four Thousand (Php 4,000.00) pending the receipt of the MOOE for connectivity. (DO No. 50, s. 2009);
  - e. All high schools with computer laboratories connected to a Local Area Network (LAN) must comply with the following bandwidth requirement:
    - 1. Within the coverage of the Telecommunication Companies:
      - For schools with at least ten (10) computers, the required speed is up to 3.5 Mbps with 256 Kbps Committed Information Rate (CIR). The type of connection can be wired or fixed wireless. (DO No. 46, s. 2011); and
  - f. Allotment under DICP shall be the soly/exclusively for payment of internet connectivity services (DO No. 46, s. 2011);
- In compliance with DepEd Order No. 50, s. 2009, recipient Schools with "Pocket Wifi" for internet connectivity are advised to discontinue the renewal of its contract with their Internet Subscription Provider (ISP).
- 4. Widest dissemination and compliance is enjoined.
