Section 8 of RA 6713, otherwise known as the "Code of Conduct and Ethical Standards for Public Officials and Employees," states that public officials and employees have an obligation to accomplish and submit declarations under oath of their assets, liabilities, net worth and financial and business interests (SALN) including those of their spouses and of unmarried children under eighteen (18) years of age living in their households. Said document must be filed on or before April 30 of every year.

Pursuant thereof, and, further, to evade the late submission of the required document to the Office of the Ombudsman, all the concerned are hereby reminded and enjoined to accomplish and submit their true and detailed SALN for the calendar year 2016 in three (3) original copies (for district/school, Division and Ombudsman) on or before March 10, 2017 (Friday) using the attached SALN form (Revised as of January 2015 per CSC Resolution No. 1500088, promulgated on January 23, 2015).

Correlatively, this Office is reiterating Division Memorandum No. 17, series of 2016 refraining Administrative Officers in Schools and Division Office from administering oaths. Attached is a copy of said memorandum.

It has been observed that several personnel in the schools and in this Office have been requesting Administrative Officers to administer oath in their Sworn Statement of Assets and Liabilities and Networth.

For the information and guidance of all concerned, quoted hereunder is Section 2 of Republic Act No. 6733, which amended Section 41 of the Administrative Code of 1987, which provides:

"Section 2. Section 41 of the Administrative Code of 1987 is hereby amended to read as follows:

Sec. 41. Officers Authorized to Administer Oath. - The following officers have general authority to administer oaths: President; Vice-President; Members and Secretaries of both Houses of the Congress; Members of the Judiciary; Secretaries of Departments; provincial governors and lieutenant-governors; city mayors; municipal mayors; bureau directors; regional directors; clerks of courts; registrars of deeds; other civilian officers in the public service of the government of the Philippines whose appointments are vested in the President and are subject to confirmation by the Commission on Appointments; all other constitutional officers; and notaries public."

Apparently, administrative officers in the Schools and Division Office are not included as one of the authorized officers to administer oaths. It is therefore directed that all Administrative Officers in School and Division Office shall refrain from administering oaths for obvious reasons.

Immediate dissemination and compliance are enjoined.
